Explanatory Notes:

(1) The total number of Vehicles included in the planned campaigns as set out above is current as at 31 August 2018, and subject to fluctuations on a daily basis due to the fact that when a 'like for like' replacement is carried out -
a. the number of vehicles in the current campaign decreases, but -
b. the number of vehicles in the planned 'like for like' expansions increases.

(2) The 'like for like' recall expansions include Corolla ZZE122 and ZZE123 (date range 2001-2007) and Yaris Sedan NCP93 (date range 2005-2008) because at the time of initial rectification of these vehicles it was necessary to use a new Affected Takata Airbag Inflator. However, Toyota Australia has recently been able to access replacement airbag inflators from a different manufacturer, and therefore has reached a 'break point' where rectification of Corolla and Yaris vehicles under Current Campaigns no longer results in the requirement for these vehicles to be further recalled in any 'like for like' recall expansion campaign.

(3) Similarly to note (2) above, in respect of the Lexus SC430 FN48Y (date range 2001-2006), the Lexus SC430 FN45Y (date range 2006-2010) and Avensis ACM20 (date range 2001-2003) that are listed in the 'like for like' recall expansions, Toyota Australia expects to reach a 'break point' for these vehicles in the near future. Once 'like for like' replacements are not carried out on these particular vehicles, then rectification under current campaigns will no longer result in the requirement for them to be further recalled in any 'like for like' recall expansion campaign.

(4) Not all vehicles in the production ranges listed in the Toyota Revised RIS are subject to a future Takata airbag recall due to notes (2) and (3) above.
